ELLIE BIRD COMMON PURPOSE GRADUATE

The following two documents show that Chief Inspector Ellie Bird completed a Common Purpose course as a senior police officer for West Midlands police. As is usual for CP this brought her into the 'leadership realm' of the German Banks. Next she moves to British Transport Police.

Installed in her new post with BTP, they spend a massive £47,000 on Common Purpose training. Ms Bird is Training Co-ordinator. In addition, and as a Common Purpose graduate herself, she then makes recommendation within BTP as to what information on Common Purpose should be released to the public. Isn't this a vested interest?

Once again we see Common Purpose graduates using their position in CP to interfere and direct the release of information under Freedom of Information, concerning the expenditure of public money.

Is this little Bird "Leading Outside Authority" as taught by Common Purpose?

Ms Bird uses the Common Purpose line 'that individuals having completed a Common Purpose course do so as an individual and therefore the public have no right to know what their training actually involved'. The public is also denied the right to judge if public money has been spent wisely so as to give 'value for money'. This is yet another example of Common Purpose using its graduates to effect Common Purpose policy within a public organisation. Without the exposure provided by this site and many other independent individuals, the general public would have no idea of the secret influence of Common Purpose 'graduates' and cells within key public organisations.

Will Common Purpose graduates breach 'protective caveats' such as Restricted, Confidential and Secret when directed to do so by Common Purpose 'Head Office'?
