Thank you for your letter dated 20th December 2005.

Please find enclosed the information that we found relevant to your request. We hope that this fully satisfies your enquiry, but should you require further information at any time please feel free to submit a new request.

Please note that we were only able to find answers to questions 1, 2 & 4 of your request. Unfortunately though, we were not able to separate out the actual amounts spent in schools. A total figure was all we could calculate from our accounting system. In addition, we were unable to highlight travel and subsistence costs related to this training. To do this would have meant searching the paper copies of staff claims and this would have taken longer than the 2.5 days specified in the Freedom of Information Act, in which we have to search for the requested information. Finally, for the same reason, we have not searched for copies of all documentation, letters, emails, faxes, relating to Common Purpose Training within Cornwall County Council (CCC). Since six CCC departments have staff who have been trained by this company, we estimate that the cost of locating, retrieving and extracting all documentation relating to your request would exceed the appropriate limit of £450 (approx 2.5 days).
