Hope you're ok and that the project is coming on well.

Three things:

1. XXXXX wondered if WAG would be in a position to make a contribution towards his fee?
2. We've had two application and an enquiry from WAG staff for Navigator. They have dates in March and May which aren't Wales dates. I think the young man who contacted Elen will probably opt for the March dates which I think are in London. The Wales dates will be in October/November, and we are probably going to split the week into 3 + 2. This will help with the energy levels of the participants, and also enable us to move further afield in Wales, rather than all in the Cardiff/Merthyr/Swansea triangle.
